## **INFORMATION FOR PRESENTERS**

Presenter Registration	All presenters are required to register for the <i>SEL Exchange</i> before the conference. A discounted registration rate of \$675 will be offered to presenters upon acceptance. (A maximum of two presenters per session are eligible for the reduced registration rate.) To receive the discounted rate, you must register by August 29, 2025. <b>Complimentary registrations will not be provided or offered.</b>
Panel Presenters	A discounted registration rate of \$675 will be offered to presenters, upon acceptance. <b>All panel presenters are required to pay and complete registration, even if presenting only one session.</b> (A maximum of two presenters per session are eligible for the reduced registration rate.)
Profile Requirement	To submit a proposal and present at the conference, you must create a profile on Cvent, the <i>SEL Exchange</i> platform. <b>Please ensure that</b> <b>all presenters for your submission have created a profile before</b> <b>submitting your proposal.</b> Presenters can continue to update their profile once it is created.
Travel Costs	CASEL does not cover any additional costs such as travel and housing.
Number of Presentations	Each prospective submitter <b>can present in no more than two sessions,</b> including panel presentations.
Presenter Commitments	<ul> <li>To be confirmed as an <i>SEL Exchange</i> presenter, all approved presenters listed in the proposal must agree to:</li> <li>Complete a speaker agreement form by June 6, 2025.</li> <li>Complete a logistics form by August 8, 2025.</li> <li>Schedule and meet with the Manager of Programming to review presentation and logistics, by September 5, 2025.</li> <li>Register for the conference by August 29, 2025, to receive the presenter discounted rate. After this date, your registration fee will be the regular rate of \$1,075.</li> <li>Use material and language that are fully respectful and inclusive of all participants across gender, race, color, ethnicity, religion, physical ability, sexual orientation, socio-economic status, and/or any other lines of difference.</li> </ul>
